NOTICE OF PROPOSED AMENDMENTS TO THE CONSTITUTION OF THE ALL PROGRESSIVES CONGRESS

APC Constitution 2014 has been in effect for almost eight years and together with judgments from Courts of competent jurisdiction, administrative experiences have revealed flaws in the Constitution. It became imperative to conduct a review of the Party's Constitution.

The Caretaker/Extraordinary Convention Planning Committee (CEPC) established a Constitution Review Committee (CRC) under the chairmanship of Prof. Tahir Mamman OON, SAN to thoroughly review the Constitution in accordance with Article 30 which provides for Constitutional amendments.

The Committee adopted an all-inclusive approach which led to the draft proposals herein provided for. Broadly, the proposals address the following:

1. Clarify ambiguities in the Constitution.
2. Fill gaps that became apparent.
3. Recognize and expand platforms for participation of critical groups such as women, youth, and persons with disabilities.
4. Replace the BOT under a new title called National Advisory Council with streamlined memberships and clear powers and functions.
5. Create zonal congresses.
6. Clarify powers of NEC and NWC.
7. Clearer accountability by organs of the party.
8. New organs for efficient administration of the party.
9. Fair distribution of income between national and sub-national organs.
10. Clarify disciplinary procedures and powers etc.

Specific provisions covering the above and other details are in the draft articles provided hereunder as follows:

- ii. Application for membership shall be made to and cleared by the Ward Executive **Committee** of the Party in the Ward of the Local Government Area where the person was born, resides, works or originates. On-line registration shall also be acceptable, provided that it is **approved** by the National Working Committee of the Party.
- iii. **Where an application is refused, the applicant may as of right appeal to the Local Government Area Executive Committee of the Party and sequentially up to the National Working Committee. In the case of on-line registration, appeals shall lie to the National Working Committee.**
- iv. **Upon enrolment, every member shall pay the prescribed fees and shall be issued a membership card.**

Provision for payment of fees

9.2 Obligations

- i. Members of the Party shall be obliged to affirm the Party's aims and objectives and conduct themselves in a manner that shall not bring the Party to public odium and disrepute. Members of the Party shall also observe the rules and regulations embedded in this Constitution.
- ii. **Members shall pay, as and when due, all dues and levies as may be prescribed by the National Working Committee and approved by National Executive Committee.**
- iii. Members shall participate in the activities of the Party **such as** election campaigns, rallies, fund raising, functions, meetings, etc.

9.3 Rights and Privileges

- i. Only fully registered and financially up-to-date members of the Party shall have the right to vote and be voted for into any elective positions, subject to the provisions made for such elections **under** this Constitution or other laws or regulations. Consequently, non-financial members shall not enjoy the above rights.
- ii. Subject to article 9.3(i) above, members shall enjoy the privileges of the Party and shall be entitled to be appointed to any committee of the Party upon the approval of the Executive Committees of the Party at the various levels.
- iii. **APC-led Governments at all levels shall accord qualified members of the party priority in appointments to positions in ministries, departments and agencies.**
- iv. **Failure to pay dues shall attract a penalty of fifty (50) percent of the accrued sum.**
- v. **The rights and privileges of defaulting members shall be suspended until payment is made and the National Working Committee approves the reinstatement of such rights and privileges.**

9.4 Register of Members

- i. A register of members shall be compiled and maintained at the Ward level and be transmitted to the Secretariat of the Party at the Local Government Area, which shall transmit a copy to the State Headquarters, which in turn shall transmit a copy to the National Secretariat. Provided that the Party shall update its membership **register** every six months and remit updated copies to appropriate Secretariats.
- ii. It shall be the responsibility of a member to ensure that his or her name is duly entered in the Ward register.
- iii. Where a group or association joins the Party, the Party shall welcome the group or association, but each member of such group or association shall register individually at their respective Wards.
- iv. Where eligible persons for membership of the Party numbering thirty (30) or more reside in any country outside Nigeria, they may establish a chapter of the Party and shall enjoy full benefits of membership; **provided that no city shall have more than one (1) chapter.**
- v. **Members residing outside Nigeria may establish one (1) national chapter in their country of residence.**
- vi. **The local and national chapters of the Party outside Nigeria shall forward the list of duly elected Executive Committee at their congresses to the National Working Committee for approval.**

Provision for diaspora chapters

9.5 Cessation of Membership

- i. Membership of the Party shall be terminated by death, resignation, expulsion **and** procurement of membership of another political party.
- ii. **A person shall cease to be a member of the Party if he accepts political appointment from another political party in government without the approval of the National Working Committee.**
- iii. Upon cessation of membership, a person shall return to the Party all its properties in his or her possession.

- iv. all serving and past members of the National Assembly, who are members of the Party from the State,
- v. all members of the National Executive Committee from the State,
- vi. all serving and past members of the State House of Assembly, who are members of the Party from the State,
- vii. all elected Local Government Areas/Area Councils Chairmen and Deputy Chairmen, who are members of the Party,
- viii. all elected Councillors of Local Government Areas/Area Councils, who are members of the Party from the State,
- ix. all Chairmen and Secretaries of the Party in the Local Government Areas of the State/Area council of the Federal Capital Territory, Abuja,
- x. five delegates per ward (at least, two of whom shall be women) elected at the Ward Congress, who shall cease to function after the conclusion of the State Congress for which they were elected, and

There shall be for each Local Government Area and Area Council Chapters of the Party, a Local Government Area/Area Council Congress consisting of:

- i. all members of the National, Zonal, and State Executive Committees from the Local Government Area/Area Council,
- ii. all members of the Local Government Area/Area Council Executive Committee,
- iii. the Chairman and Secretary of the Ward Executive Committee in the Local Government Area/Area Council,
- iv. Chairmen and Councillors of the Local Government/Area Council who are members of the Party,
- v. five Delegates, at least two of whom shall be women, from each Ward of the Local Government Area/Area Council elected at the Ward Congress who shall cease to function after the Local Government Area/Area Council Congress for which they were elected, and
- vi. all statutory members of the State Congress from the Local Government Area/Area Council.

 - viii. past Speakers, Deputy Speakers and other principal officers of State Houses of Assembly, who are members of the Party,
 - ix. past members of the National Working Committee and any organ created by the Party to exercise the powers and functions of the National Working Committee,
 - x. members of the States' Working Committee, including the Federal Capital Territory, Abuja,
 - xi. all Party Chairmen and Secretaries of the Local Government Areas/Area Councils in the country, who are members of the Party,
 - xii. all elected Local Government Council/Area Council Chairmen, who are members of the Party,
 - xiii. three elected delegates (at least one of whom shall be a woman) from each Local Government Area/Area Council,
 - xiv. the National Secretary and National Organising Secretary of each wing of the Party, and
 - xv. the Chairman and Secretary of the Committee of Diaspora Chairmen.

12.2 National Advisory Council

A. Composition

The National Advisory Council shall comprise of:

- i. past and present Presidents and Vice Presidents of the Federal Republic of Nigeria, who are members of the Party,
- ii. past and serving Senate Presidents and Deputy Senate Presidents of the Federal Republic of Nigeria, who are members of the Party,
- iii. past and serving Speakers and Deputy Speakers of the House of Representatives, who are members of the Party,
- iv. past and serving National Chairmen produced by the All Progressives Congress,
- v. past National Secretary of the Party
- vi. past and serving Secretary to the Government of the Federation who is a member of the Party
- vii. one serving Governor from each geo-political zone,
- viii. the Deputy National Chairmen,
- ix. the National Secretary,
- x. the National Legal Adviser,
- xi. the National Woman Leader,
- xii. the National Youth Leader,
- xiii. the National Leader of Persons Living with Disabilities, and
- xiv. two eminent members of the Party from each geo-political zone, one of whom shall be a woman, to be nominated by the zonal caucus.

B. Qualification/Eligibility for Membership.

Pursuant to the provisions of article 12.2(A) above, a registered member of the Party shall be eligible for membership of the National Advisory Council if:

- i. He has not been convicted by a Court of competent jurisdiction for an offence involving fraud or dishonesty.
- ii. He has not been adjudged to be a lunatic or otherwise declared to be of unsound mind under any Law in force in any part of Nigeria.
- iii. He has not been adjudged or declared bankrupt.
- iv. He has not been impeached from any office in the Federation; State and Local Government Area/Area Council or dismissed from public or private service.
- v. He is a person of proven integrity, impeccable character and verifiable track record of service to humanity.

- iii. The constitution, rules and regulations of the Women's Wing shall not be in conflict with the Constitution, guidelines and policies of the Party.
- iv. The constitution of the Women's Wing shall be subject to the approval of the National Executive Committee of the Party.
- v. The National Woman Leader shall be the leader of the Women's Wing.

12.20 Youth Wing

- i. Membership of the Youth Wing shall be open to all youth, as defined in this Constitution, who are members of the Party.
- ii. The Youth Wing shall function as an autonomous body within the overall structure of the Party, of which it shall be an integral part, and subject to the supervisory and disciplinary powers of the Party.
- iii. The constitution, rules and regulations of the Youth Wing shall not be in conflict with the Constitution, guidelines and policies of the Party.
- iv. The constitution of the Youth Wing shall be subject to the approval of the National Executive Committee of the Party.
- v. The National Youth Leader shall be the leader of the Youth Wing.

12.21 Persons Living with Disabilities Wing

- i. Membership of the Persons Living with Disabilities Wing shall be open to all persons living with disabilities, who are members of the Party.
- ii. The Persons Living with Disabilities Wing shall function as an autonomous body within the overall structure of the Party, of which it shall be an integral part, and subject to the supervisory and disciplinary powers of the Party.
- iii. The constitution, rules and regulations of the Persons Living with Disabilities Wing shall not be in conflict with the Constitution, guidelines and policies of the Party.
- iv. The constitution of the Persons Living with Disabilities Wing shall be subject to the approval of the National Executive Committee of the Party.
- v. The National Leader of the Persons Living with Disabilities shall be the leader of the Persons Living with Disabilities Wing.

ARTICLE 13: POWER OF PARTY ORGANS

13.1 National Convention

The final authority of the Party shall rest with the National Convention, which shall have the power to:

- i. Ratify policies and programmes of the Party.
- ii. Elect or remove National Officers of the Party.
- iii. Elect the Presidential Candidate of the Party.
- iv. Receive reports from the National Executive Committee and from any other Committee and or organ of the Party; and take appropriate decisions on the reports and or recommendations.
- v. Amend the Constitution of the Party from time to time as the need may arise.
- vi. Delegate any of its powers to the **National Advisory Council**, National Executive Committee or to any other organ of the Party.
- vii. Take any action as may be conducive to the promotion of the aims and objectives of the

- Party as laid down in this Constitution.
- viii. Appoint External Auditors to audit the Party's accounts for its consideration.
- ix. Exercise such other powers and authority as are vested in it by this Constitution.
- x. Ratify the minimum rate of annual subscription to be paid by members and the proportion of income from subscriptions to be remitted to the National Secretariat of the Party.

13.2 National Advisory Council

A. Powers

The National Advisory Council shall:

- i. Be the conscience and soul of the Party, and shall represent and demonstrate the highest standard of morality in the Party.
- ii. It shall, when necessary, intervene in all disputes and crises in the Party to ensure its stability at all times.
- iii. Advise on, and when necessary, initiate policies for the guidance of the Party.
- iv. Promote reconciliation, encourage and facilitate the settlement of disputes in an amicable manner among members of the Party.
- v. By decision of a simple majority of its members, convene the National Convention, the National Executive Committee or National Caucus to hold statutory meetings of the Party where they are unable or unwilling to meet.
- vi. Regulate its own proceedings and formulate a Code of Conduct for its members.
- vii. Perform any other functions referred to it by the National Executive Committee and/or National Convention.
- viii. Elect its Chairman, Deputy Chairman, Secretary and other officers as it deems necessary, and formulate its own rules and procedures to regulate its meetings and activities.

B. Tenure

- i. The National Secretary shall, not later than one month after an elective convention, convene the meeting of the National Advisory Council at which its first leadership, including the Chairman, Deputy Chairman, Secretary and other officials that may be deemed necessary, shall be constituted.
- ii. The tenure of the members of the National Advisory Council, other than those specified in article 12.2 (A) (i-iv), shall be four (4) years, subject to renewal for another four (4) years and no more.
- iii. The President of the Federal Republic of Nigeria, who is a member of the Party, shall serve as Chairman of the National Advisory Council and shall serve in that capacity upon completion of his term as President for the period prescribed in this Constitution.

Provide clear functions, responsibilities, leadership and tenure

13.3 National Executive Committee:

A. The National Executive Committee of the Party shall be the Principal Executive body of the Party and shall perform the following functions:

- i. Summon or convene the National Convention and prepare its agenda.
- ii. Discharge all functions of the National Convention in- between National Conventions.
- iii. Decision of the National Executive Committee shall be binding on all organs and all members of the Party, except the National Convention.
- iv. Consider reports from National, State and Local Government Area/Area Councils Chapters of the Party and take such decisions as are necessary to protect, advance, and consolidate the gains and interest of the Party.
- v. Exercise control and take disciplinary actions on all organs, officers and members of the Party and determine appeals brought before it by any member or organ of the Party.
- vi. Create, elect and appoint any Committee it may deem necessary, desirable or expedient and assign to them such powers and functions as it may deem fit and proper.
- vii. Examine the actions taken or legislation proposed or passed by any Government, Legislative House or Local Government Area/Area Council and determine what further actions the Party should take.
- viii. Secure at all elections the return of as many Party candidates as possible, so as to generally have control of the Legislative and Executive arms of Governments in the Federation, States and Local Government Areas/Area Council.
- ix. Raise adequate funds for the management and sustenance of the Party.
- x. Ratify the type, nature and membership of Standing Committees to be set up by the National Working Committee.
- xi. Approve the nomination of members of standing committees as shall be recommended by the National Working Committee.
- xii. Ensure that the actions and policies of the government at the Federal and State levels are consistent with the Party's manifesto and campaign promises.
- xiii. Conduct due diligence on nominees considered for statutory positions before transmission to the Senate for confirmation.
- xiv. Approve the national budget of the Party.
- xv. Receive quarterly financial report from the National Working Committee on income and expenditure of the Party.
- xvi. Appoint external auditor.

B. Notwithstanding anything to the contrary in this Constitution, the National Executive Committee shall have the power to set up a Caretaker Committee in place of any organ at all levels, except the National Advisory Council and National Convention, where in its opinion there is a compelling situation warranting such action in the overriding interest of the Party.

C. Any such Committee shall have a defined tenure not exceeding twelve (12) months.

13.4 The National Working Committee

The National Working Committee shall be responsible for the Administration of the Party and putting into effect the decisions of the National Executive Committee. To this end, the National Working Committee shall carry out the day-to-day running of the affairs of the Party. It shall in particular:

- i. Prepare the agenda for the National Convention subject to ratification by the National Executive Committee.
- ii. Prepare and submit reports and budgets for consideration of the National Executive Committee.
- iii. Provide financial guidelines for the consideration of the National Convention subject to the ratification of the National Executive Committee.
- iv. Prepare and present quarterly financial report to the National Executive Committee on income and expenditure of the Party.
- v. Propose policies and programmes for the Party, which shall be considered by the National Executive Committee.
- vi. Propose electoral guidelines and regulations governing the conduct of elections to Party offices at all levels, and procedure for selecting Party candidates for elective offices, subject to the provisions of this Constitution, to the National Executive Committee.
- vii. Propose policies and programmes for the Party for consideration by the National Executive Committee.
- viii. Invite such person(s) as it deems necessary, desirable or expedient, to attend meeting(s) and take part in deliberations provided that such invited person(s) shall have no voting right.
- ~~ix.~~ Consider appeals and other issues referred to it by the State Working Committee, and/or emanating from the zones and States of the Federation.
- x. Establish ad-hoc and/or standing committees, appoint members to such committees and empower the committees to function for the smooth administration of the Party.
- xi. Examine the activities, policies, programmes and legislation made by the governments in the Federation, from time to time, in order to determine their alignment with the manifesto and Constitution of the Party, and when necessary, to make recommendations to the National Executive Committee for its action.
- xii. Recommend to the National Executive Committee for its approval, the proportion of income from subscriptions from Wards, Local Government Areas/Area Councils and States that shall be remitted to the National Secretariat.
- ~~xiii.~~ Organise primary elections for the nomination of its Presidential, Governorship, National and State Legislative Assembly candidates.
- xiv. Subject to the approval of the National Executive Committee, the National Working Committee may in special circumstances grant a waiver to a person not otherwise qualified under this Constitution if in its opinion, such a waiver is in the best interest of the Party.
- xv. The National Working Committee shall have the power to create and appoint committees it may deem necessary, desirable or expedient and assign to them such powers and functions as it may deem fit and proper for the discharge of its functions.
- xvi. The National Working Committee shall liaise with governments formed by the Party at all levels with a view to ensuring that members of the Party are accorded priority in appointments into public offices, and shall provide periodic reports in this regard to the National Executive Committee.
- xvii. The National Working Committee shall at the quarterly meetings of the National Executive Committee present quarterly report containing the activities of the Party.

Provide additional responsibilities and functions

13.5 Zonal Executive Committee:

The Zonal Executive Committee shall meet to transact any or all of the following:

- i. Attend to all political and organisational matters affecting the zone.
- ii. Coordinate Party activities at the Zonal level.
- iii. Liaise with the State Executive Committees on ways and means of strengthening the Party within the zone.
- iv. Perform such other advisory and consultative functions as may be directed by the National Working Committee and National Executive Committee.

13.6 Zonal Congress

The Zonal Congress shall exercise the following powers:

- i. Elect officers of the Zonal Executive Committee.
- ii. Approve the budget of the Party on the zone.
- iii. Receive reports of officers of the Party in the zone.
- iv. Delegate any of its powers to the Zonal Executive Committee.

Provide for electing Zonal offices in the zones.

13.7 State Congress

The State Congress shall exercise the following powers:

- i. approve the budget of the Party in the State,
- ii. elect officers of the State Executive Committee,

- iii. liaise with the State Executive Committee on ways and means of strengthening the Party within the District, and
- iv. perform such other advisory and consultative functions as may be directed by the State Executive Committee.

13.11 Local Government Area Congress

The Local Government Area Congress shall:

- i. elect members of the Local Government Area/Area Council Executive Committee of the Party,
- ii. elect Local Government Party Delegates to the State Congress and the National Convention,
- iii. approve the budgets for the running of the Party at the Local Government Area/Area Council Levels, and
- iv. receive Auditor's Report.

13.12 Local Government Area Executive Committee

The Local Government Area Executive Committee shall:

- i. Attend to issues (political, social and economic) of concern to the Party in the Local Government Area/Area Council.
- ii. Receive reports from the constituent Wards on:
 - a) membership drive,
 - b) fund-raising activities,
 - c) mobilisation of voters, and
 - d) strategies for political campaigns and electoral success.
- iii. Responsible for the distribution and utilization of materials in the Wards.
- iv. Provide strategies for effective communication between the Wards and Local Government Areas/Area Councils.
- v. Implement decisions of the Local Government Area/Area Council Congresses and other organs of the Party.
- vi. Regulate the employment of Secretariat staff of the Party in the Local Government Area/Area Council.

13.13 Ward Congress:

The Ward Congress shall:

- i. approve the budget for the Ward,
- ii. elect members of the Ward Executive Committee,
- iii. elect Ward delegates to the Local Government Area/Area Council and State Party Congress,
- iv. receive reports from the officers of the Ward, and
- v. undertake any other business in the interest of the Party within the Ward.

13.14 Ward Executive Committee:

The Ward Executive Committee shall:

- i. attend to the day-to-day administration of the Party at the Ward level,
- ii. raise funds for the day-to-day administration of the Party at the Ward level,
- iii. engage in membership drive,
- iv. provide strategies for political campaign,
- v. engage in the Mobilisation of voters,
- vi. implement decisions of Ward Congresses and other organs of the Party, and
- vii. perform such other functions as may be in the interest of the Party.

13.15 Polling Unit Committee

- members of the Party,
- iv. current Local Government Council/Area Council Chairmanship and Deputy Chairmanship Candidates of the Party,
 - v. Local Government Area/Area Council Party Secretary,
 - vi. Local Government Area/Area Council Councillors, who are members of the Party,
 - vii. Local Government Area/Area Council Party Treasurer,
 - viii. all Ward Party Chairmen,
 - ix. Local Government Area/Area Council Women Leader,
 - x. Local Government Area/Area Council Youth Leader,
 - xi. Local Government Area/Area Council Leader of Persons Living with Disabilities,
 - xii. such other members, in equal proportion of men and women, as may be co-opted or appointed by the Local Government Area/Area Council Executive Committee of the Party, and
 - xiii. all statutory members of the State Caucus from the Local Government Area/Area Council.

- vi. the Ward Assistant Treasurer,

- ix. the Ward Organising Secretary,
- x. the Ward Assistant Organising Secretary,
- xi. the Ward Publicity Secretary,
- xii. the Ward Assistant Publicity Secretary,
- xiii. the Ward Welfare Secretary (**who shall be a woman**),
- xiv. the Ward Assistant Welfare Secretary,
- xv. the Ward Woman Leader,
- xvi. the Ward Assistant Woman Leader,
- xvii. the Ward Youth Leader,
- xviii. the Ward Assistant Youth Leader (**who shall be a woman where the Ward Youth Leader is a man**),
- xix. the **Ward Leader of Persons Living with Disabilities**,
- xx. the **Ward assistant Leader of Persons Living with Disabilities (who shall be a woman where the Ward Leader of Persons Living with Disabilities is a man)**,
- xxi. the Ward Auditor,

The Polling Unit Committee shall:

- i. be responsible for ensuring the success of the Party at all elections, and
- ii. carry out such assignments as may be given by the Ward Executive Committee.

ARTICLE 14: POWERS OF NATIONAL OFFICERS

14.1 National Chairman

The National Chairman shall:

- i. Preside over the meetings of the National Executive Committee and the National Working Committee of the Party.
- ii. Provide **efficient** and effective leadership to the Party.
- iii. Uphold the Constitution and defend the name, policies and programmes of the Party.
- iv. Be a signatory to the accounts of the Party.
- v. Direct the due execution of the programmes of the Party.
- vi. Give lawful directives to all officers, organs, and members of the Party at all levels.
- vii. Have a casting vote in the event of a tie in the meetings of the Party over which he presides.
- viii. Ensure the implementation of the directives of all superior organs of the Party, namely the National Convention, the Board of Trustees, the National Executive Committee, the National Working Committee and the National Caucus.
- ix. Perform such other functions as may be assigned to him from time to time by the National Convention, **National Advisory Council**, National Executive Committee and/or the National Working Committee.
- x. **The National Chairman shall preside over all statutory meetings of the Party at the National level, except the meetings of the National Advisory Council.**

For Clarity

14.2 Deputy National Chairmen, North/South

The Deputy National Chairmen shall:

- i. assist the National Chairman in the discharge of his duties,
- ii. perform such functions as may be assigned to him, from time to time by the National Executive Committee and National Working Committee,
- iii. shall act as the National Chairman in the absence of the National Chairman from his Zone, and
- iv. **provide supervisory role within the zone.**

14.3 National Secretary

The National Secretary shall:

- i. Be the head of the National Secretariat, and supervise its day-to-day activities.
- ii. Issue notices of meetings of the National Convention, National Executive Committee and National Working Committee of the Party.
- iii. Maintain all records and books of proceedings of the National Convention, National Executive Committee and National Working Committee of the Party.
- iv. Render a written annual report of the activities of the Party to the National Executive Committee.
- v. Carry out any other duty as may be assigned to him from time to time by the National Convention, National Advisory Council, National Executive Committee, National Working Committee, and National Chairman.
- vi. Be a co-signatory to the Party's Account(s).
- vii. Serve as the Secretary of all statutory meetings of the Party.

14.4 Deputy National Secretary

The National Vice Chairman shall:

- i. coordinate the activities of the Party in the geo-political zone, and
- ii. shall perform such functions as may be assigned to him from time to time by the National Executive Committee and National Working Committee.

14.6 National Treasurer

The National Treasurer shall:

- i. receive and promptly, not later than 24 hours, pay into the Party's accounts all monies received for and on behalf of the Party,
- ii. ensure prudent management of Party funds,
- iii. prepare and submit quarterly and yearly statements of account to the National Executive Committee, and
- iv. be a signatory to the accounts of the Party.

14.7 Deputy National Treasurer

The Deputy National Treasurer shall:

- i. assist and deputise the National Treasurer, and
- ii. perform such functions as may be assigned to him from time to time by the National Treasurer.

14.8 National Financial Secretary

The National Financial Secretary shall:

- i. collect all monies due to the Party and pay such monies to the National Treasurer not later than 24 hours after the collection,
- ii. prepare and submit proposals for raising Party funds for the consideration of the National Working Committee,
- iii. ensure that proper account and records are kept and cause such books to be produced for inspection as may be required, and
- iv. be a co-signatory to the accounts of the Party.

14.9 Deputy National Financial Secretary

- i. assist and deputise the National Financial Secretary, and
- ii. perform such functions as may be assigned to him from time to time by the National Financial Secretary.

14.10 National Publicity Secretary

- i. be the official spokesperson of the Party,
- ii. be responsible for dissemination of the Party's information and promotional activities of the Party, and

14.16 National Auditor

The National Auditor shall:

- i. audit the books of account of the Party annually and report accordingly to the National Working Committee which shall in turn transmit same to the National Executive Committee.

- iii. from time to time, examine the books of accounts of the Party.

14.17 Deputy National Auditor

14.18 National Legal Adviser

The National Legal Adviser shall:

- iii. **Attend to** litigations and legal defence on behalf of the Party **at all levels**, including its organs, officials and assets.

- v. **Be responsible for engaging external retainers, where desirable, and counsel to handle all litigations involving the Party at all levels, with the approval of the National Working Committee.**
- vi. **Ensure that the Party, in all its activities, is guided by the Constitution of the Federal Republic of Nigeria, statutory laws, Party Constitution and guidelines.**
- vii. **Ensure that the credentials of all aspirants seeking elective offices on the platform of the Party are submitted to the Legal Department for vetting and issuance of advisories to the Screening Committees of the Party.**
- viii. Give legal opinion on all laws, regulations and the Constitution of the Party in the event of ambiguities.
- ix. Shall be the Legal Adviser to the **National Advisory Council.**

14.19 Deputy National Legal Adviser

- ii. assist and deputise the National Legal Adviser, **and**

The National Woman Leader shall:

- vi. Deal with any other matters referred to it by the State Executive Committee or the State Congress.
- vii. Establish ad-hoc and/or standing committees of the Party and appoint members to such Committees within the State, provided that such committees shall not conflict with the powers and functions of any Committee set up by the National Executive Committee and the National Working Committee.

Where either the complainant or the Party against whom a complaint is made, makes out a *prima facie* case of bias, intimidation or undue influence or likelihood of same by the Executive Committee seized with original jurisdiction to hear and determine such a matter, or a member thereof; or where the complaint is against a Party organ at that level, making it impracticable to appoint a fact-finding committee:
 - a) Such complaint shall be transferred to the next higher organ seized with appellate jurisdiction to hear and determine such matters.
 - b) In the case of allegation against an officer at any level, such officer shall not participate in the appointment of a fact-finding committee.
- vi. For the purpose of article 21 of this Constitution:
 - a) The Ward Executive shall be the adjudicatory body of first instance over complaint and or allegation from the Polling Unit level.
 - b) The Local Government Area Executive Committee shall be the adjudicatory body of first instance over complaints or allegations from the Ward level.
 - c) The State Executive Committee shall be the adjudicatory body of first instance over complaints or allegations from the Local Government Area/Area Council level.
 - d) The Zonal Committee shall be the adjudicatory body of first instance over complaints or allegations from the State Chapter in the zone.
 - e) The National Executive Committee shall be the adjudicatory body over complaints and allegations from the zones.

21.4 Appeals

The right of appeal of an aggrieved member of the Party is hereby guaranteed.

The procedure for appeals shall be as follows:

- i. Where a member is not satisfied with the decision of any of the adjudicatory organs of the Party, he shall have the right to appeal within **seven** (7) days of the decision to the immediate appellate body in the Party as prescribed in this Constitution.
- ii. An appeal shall be determined by the appropriate appellate body within **fourteen** (14) days from the date of receipt of the appeal by the appellate body concerned.
- iii. Where a decision or action taken by an Organ of the Party is appealed against, the decision or action shall remain in force and binding until the appeal has been determined. **However, the appellate body may, in the interest of justice, stay the execution of such decision or action pending the determination of the appeal.**
- iv. An appeal from the decision of the Ward Executive Committee, on a complaint originating from the Ward shall lie to the Local Government Area Executive Committee and thereafter to the **State Executive Committee which decision shall be binding and thereafter sequentially lie up to the National Working Committee.**
- v. An appeal from the decision of the Ward Executive Committee, as an adjudicatory body of first instance, on a complaint originating from the Ward shall lie to the Local Government Area Executive Committee and thereafter to the State Executive Committee **which decision shall be binding and thereafter sequentially lie up to the National Working Committee.**
- vi. An appeal from the decision of the Local Government Area Executive Committee on a complaint originating from the Local Government Area Chapter shall lie to the State Executive Committee and thereafter to the Zonal Executive Committee **which decision shall be binding and thereafter lie to the National Working Committee.**
- vii. An appeal from the decision of the State Executive Committee, as an adjudicatory body of first instance; on a complaint originating from the Local Government Area Chapter shall lie to the Zonal Executive Committee **which decision shall be binding and thereafter sequentially lie up to the National Working Committee.**
- viii. An appeal from the decision of the State Executive Committee on a complaint originating from the State shall lie to the Zonal Executive Committee and thereafter to the **National Working Committee** which shall be binding on the Parties.
- ix. An appeal from the decision of the Zonal Executive Committee, as an adjudicatory body of first instance, on a complaint originating from the State Chapter shall lie to the **National Working Committee** and thereafter to the **National Executive Committee** which decision shall be binding on the Parties.
- x. An appeal from the decision of the National Executive Committee on a complaint originating at the National level shall lie to the **National Convention.**

21.5 Punishment of Erring Members:

- i. The Party shall have power to impose the following sanctions on members in accordance with the nature and gravity of the offence:
 - a) reprimand,
 - b) censure,
 - c) fine,
 - d) debarment from holding Party office,
 - e) removal from Party office,

**ARTICLE 25:
MEETINGS**

25.1 National Convention

The National Convention of the Party shall be held once **every** two (2) years at a date, venue and time to be recommended by the National Working Committee and approved by the National Executive Committee, subject to the **issuance** of the statutory notices to the Independent National Electoral Commission and at least fourteen (14) days notice given to members eligible to attend.

- i. Without prejudice to **the foregoing**, the National Executive Committee may summon an emergency National Convention at any time, provided at least seven (7) days notice of the meeting shall be given to all members eligible to attend.
- ii. The quorum for the meeting of the National Convention shall be one-third of its membership.
- iii. The provisions regulating the meetings of the National Convention shall apply *mutatis mutandis* to State Congresses, Local Government Area/Area Council Congresses and Ward Congresses.

25.2 National Executive Committee

- i. The National Executive Committee shall meet every quarter and or at any time decided by the **National Working Committee** or at the request made in writing by **one-third** of the members of the National Executive Committee, provided that not less than fourteen (14) days notice is given for the meeting.
- ii. Without prejudice to **the provisions of sub-article (i) above**, the National Working Committee may summon an emergency National Executive Committee meeting at any time, provided that at least three (3) days notice of the meeting shall be given to all **persons** entitled to attend.
- iii. Decisions at the meeting of the National Executive Committee shall be by simple majority of members present and voting.
- iv. Quorum for meetings of the National Executive Committee shall be one-third of its membership.
- v. The provisions regulating the meetings of the National Executive Committee shall apply *mutatis mutandis* to Zonal **Executive** Committee, State Executive Committee, Senatorial District Executive Committee, Local Government Area/Area Council Executive Committee and Ward Executive Committee.

25.3 National Working Committee

- i. The National Working Committee shall meet at least once every month.
- ii. **The National Chairman may convene a meeting of the National Working Committee at any time, provided notice is given to the members.**
- iii. Without prejudice to the provisions of **sub-article (i) above**, the meeting of the National Working Committee may be summoned on a request made in writing by **one-third** of members of the National Working Committee at any time, provided that at least forty-eight (48) hours notice of the meeting shall be given to all those entitled to attend.
- iv. Decisions at the meetings of the National Working Committee shall be by simple majority of members present and voting.
- v. The quorum for the meetings of the National Working Committee shall be one-third of its membership.
- vi. The provisions in **this sub-article**, shall apply *mutatis mutandis* to the State Working Committee and Local Government Area/Area Council Working Committee.

25.4 Zonal Executive Committee

- i. The Zonal **Executive** Committee shall meet at least once every quarter.
- ii. A special or emergency meeting of the Zonal **Executive** Committee shall be held as and when necessary.
- iii. Decisions at the meetings of the Zonal **Executive** Committee shall be by simple majority of members present and voting.
- iv. The quorum for the meetings of the Zonal **Executive** Committee shall be one-third of its membership.
- v. The provisions of **this sub-article**, shall apply *mutatis mutandis* to the Senatorial District meetings.

25.5 Polling Unit Committee

- i. The Polling Unit Committee shall meet every month and or at any other time **as may be** decided by the Chairman or at the request of majority of its committee members, provided **that** not less than **twenty-four (24) hours** notice **shall be** given for the meeting.
- ii. Without prejudice to the provisions of **sub-article (i) above**, the Polling Unit Committee may summon an emergency Committee meeting at any time provided that at least **twenty-four (24) hours** notice **shall be** given to members eligible to attend.
- iii. Decisions at the meetings of the Polling Unit Committee shall be by simple majority of members present and voting.
- iv. Quorum for the meetings of the Polling Unit Committee shall be **one-third of its members**.

ARTICLE 31:

OMINIBUS PROVISIONS

31.1 Gender and Affirmative Action

- i. In demonstration of the Party's commitment to ensuring greater participation of women in its affairs and government at all levels, the Party shall work towards the progressive realisation of gender equity.
- ii. The National Working Committee shall design the mechanism for achieving this objective, subject to the approval of the National Executive Committee.

Amended to provide for affirmative action for women

31.2 Nominations

In furtherance of the provisions of this Constitution regarding nominations to elective offices:

- i. No person shall be eligible to contest for any Party position or office or be nominated by the Party to be its candidate at any election, if the person is not a member of the Party.
- ii. All nominations into elective offices shall be supported by a specified number of nominators from the relevant constituencies as may be prescribed or provided for in the Party's Electoral Guidelines.
- iii. Any Party office holder interested in contesting for an elective office (whether party office or office in a general election) shall resign and leave office 30 days prior to the date of election or Party primary for the office sought.

31.3 Waiver

- i. Subject to the approval of the National Executive Committee, the National Working Committee may, in special circumstances, grant a waiver to a person seeking a national Party office, who is otherwise not qualified under this Constitution if, in its opinion, such a waiver is in the best interest of the Party.
- ii. Subject to the approval of the National Executive Committee, the National Working Committee may, in special circumstances, grant a waiver to a person seeking the office of President, Vice President, Governor, Deputy Governor, Senator, member of the House Representatives, who is otherwise not qualified under this Constitution if, in its opinion, such a waiver is in the best interest of the Party.
- iii. Subject to the approval of the State Executive Committee, the State Working Committee may, in special circumstances, grant a waiver to a person seeking election to a party office at the State level and below or office of member of House of Assembly and below, who is otherwise not qualified under this Constitution if, in its opinion, such a waiver is in the best interest of the Party.

Provide for clarity and extension to State level

31.4 Conditions for Waiver

A person may be granted a waiver only on condition that:

- i. He has not been convicted by any court of competent jurisdiction for any criminal offence.
- ii. He has applied for waiver in writing to the National Working Committee/State Working Committee of the Party.
- iii. He has signed an undertaking to uphold and implement the manifesto of the Party in the event of winning the election.

Provide for method for filling vacancies for elected officers

31.5 Vacancy

In the event of vacancy, the office shall be filled as follows:

- i. In the case of a National/Zonal Officer, the State Executive Committee shall propose a replacement to the State Congress and Zonal Executive Committee for endorsement. Thereafter, the name shall be sent to the National Working Committee, which shall forward same to the National Executive Committee for approval.
- ii. In the case of State Officer, the Local Government/Area Council Executive Committee shall propose a replacement to the Local Government /Area Council Congress for endorsement. Thereafter, the name shall be sent to the State Executive Committee for approval.
- iii. In the case of Local Government/Ward Officer, the Local Government/Ward Executive Committee shall propose a replacement to the Local Government/Ward Congress for endorsement. Thereafter, the name shall be sent to the Local Government Executive Committee for onward transmission to the State Executive Committee for approval.
- iv. The names and designations of officers in (i)–(iii) above, shall be forwarded to the National Working Committee.
