## ENUGU STATE OF NIGERIA 2015, No. 2

A Law to Amend the Enugu State Judicial Service Commission Law, Cap. Titl 60 Laws of Enugu State 2004.

BE IT ENACTED by the Enugu State House of Assembly as follows

Enactment.

This Law may be cited as the Enugu State Judicial Service Commission (Second Amendment) Law, 2015, and shall be deemed to come into force on the 27th day of October, 2015.

Citation and date of commencement.

 In this Law,
 "Principal Law" means Enugu State Judicial Service Commission Law, Cap. 60 Laws of Enugu State 2004.

Interpretation.

3. The Principal Law is amended as follows -

Amendment of the Principal law.


- (a) by substituting the phrase "one member" in line one of section 4(d) thereof with the phrase "two members",
- (b) by substituting the phrase "one other person" in line one of section 4 (e) thereof with the phrase "two other persons".
